REGISTRATION:

Available now through May 8th, 2026 Pre-registration cost is \$65 per stall mail-in, online costs are \$68 per stall. Vendor stalls may be sold at the Fairgrounds during the event if they are available starting at 10 a.m. on Friday May 15th. **This year the State of Washington requires any vendor who spends over \$200 to participate "that a valid registration certificate number issued by the department of revenue is required for participation in the special event and requires vendors to indicate their registration certificate number on these contracts": The state can issue Temporary Registration here: <https://dor.wa.gov/contact/temporary-registration-certificate>.**

VENDOR APPLICATION:

Enclosed please find a Vendor Application and General Rules for your convenience in registering for the 2026 Monroe Auto Swap Meet at the Evergreen State Fairgrounds in Monroe, May 16th & May 17th 2026. We offer **returning vendors** first choice in registering their prior year stall(s). If a completed **Returning Vendor Application and payment** have not been received by February 28th, 2026, the stall(s) will open to all **NEW Vendors** who have submitted an application and payment beginning January 1st, 2026. These New Vendor Applications will be processed by the date received. If no stall(s) are available, your application and payment will be returned.

VENDOR MIRROR TAG – SALES AREA ACCESS – VENDOR PARKING:

All vendors will be issued a Vendor Mirror Tag for each stall purchased. Vendor Mirror Tags will be required to enter the Sales Area during the Vendor Set-up times as outlined on the enclosed General Information sheet. ***No vehicle will be admitted to the Sales Area without displaying the Vendor Mirror Tag on their front windshield!*** Your cell phone number must also be written and displayed on the Mirror Tag. This Tag must remain in the vehicle at all times or the vehicle may be towed. Yes, this means that if one stall is purchased, only one vehicle will be admitted! *You may also purchase a Vendor Assist Tag for \$20 that allows an additional vehicle to help unload, these will be available at the parking lot or online.* The Vendor Mirror Tag must also be displayed in the front windshield to park in the Vendor Parking Lot. No vehicle will be admitted to the vendor parking lot without a Mirror Tag displayed properly including a **cell number**. Unauthorized vehicles without mirror tags will be towed.

GENERAL INFORMATION

WEBSITE www.monroeswapmeet.com or www.efv8psrg.org (Applications & information available on line!)

RV SPACES

RV spaces located **INSIDE** the Sale Area by the Vendor Parking Lot are available for use from noon on Friday until 4:30 pm on Sunday. All spaces have water & electricity (110 volt 30 amp outlet & 110 volt 15 amp outlet), RV owner responsible for adapters. No sewer available. Gray water is NOT to be dumped or drained on the grounds. Dump station is located in both the RV2 & RV1 location which is operated by the Fairgrounds. RV vendors are subject to all Swap Meet Rules and Regulations. These spaces are limited and **require advanced reservation** with a prepayment of \$75 per stall/night for the event. The Fairgrounds OUTSIDE RV spaces are available from the Fairgrounds reservations at www.evergreenfair.org or call 360-805-6700.

VENDOR PARKING

Vendor Parking spaces will be issued on a first come, first served basis. ***The Vendor Mirror Tag must be displayed in the front windshield to park in the Vendor Parking Lot and include a cell number.*** No vehicle will be admitted to the Vendor Parking Lot without a Mirror Tag displayed properly. Vendor parking is included with your stall rental.

LONG TRAILERS

Trailers longer than 20' must be parked in extra-long stalls. Stalls in areas 406, 31, 601, and 609 have stalls that are 30' long. You can also rent two stalls side by side to accommodate long trailers. ***The Fire Marshal will not allow you to extend beyond the Fire Lane under any circumstances.*** Violators will be asked to leave the swap meet, please don't break the rules!

CAR CORRAL - Cars for sale

Car Corral stalls are purchased at the Fairgrounds on the day(s) of the event for the sale of vehicles. We do allow unfinished cars and projects on trailers (\$60) plus motorcycles (\$50). No merchandise is to be displayed, offered for sale, or sold in the Car Corral. Vehicle movement will be allowed in the Car Corral during sale hours as approved by the Car Corral personnel. Entrance to the Car Corral is on 179th Avenue SE. ***There will be no pedestrian access allowed into the Car Corral area from the 179th Street entrance, you must walk in through the Red Parking Tunnel.*** Stalls are approximately 10' x 20' in size and cost **\$50 cash** per vehicle, regardless of how long the stall is occupied. Once the stall is empty, it will be available for resale, unless otherwise approved by the Car Corral personnel.

PARTS PICKUP POLICY

There is a dedicated parts pickup area on the east side of the fairgrounds in the Car Corral. Drive into the Car Corral, identify yourself requesting parts pickup. A refundable \$20 deposit is required to park for no longer than one hour in our designated area. We will have a number of 4H kids with wagons available to help pickup and return your parts to the Car Corral. Our Parts Pickup Czar will be there to help with any issues.

CONFIRMATION

Once this **signed application** is completed and payment received for the reservations requested, you will receive a confirmation notification from The Puget Sound Regional Group #18 of the Early Ford V-8 Club of America (PSRG) who will be sponsoring the 53rd Annual Monroe Auto Swap Meet. Mirror tags will be mailed as soon as possible.

MONROE AUTO SWAP MEET

Evergreen State Fairgrounds – Monroe, Washington

GENERAL RULES

Vendors are reminded that this is a TWO DAY MEET and are strongly urged to stay both days!

1. No vehicle movement will be allowed in the Sale Area between the hours of 8:00 am to 5:00 pm on Saturday and 8:00 am to 2:00 pm on Sunday EXCEPT Swap Meet and Fairground vehicles. There is absolutely no early exit allowed, Snohomish County Sheriff Officers will be on hand to manage the exit gates.
2. Any vehicle left unattended, other than in a vendor space registered to the vehicle owner, will be subject to towing and impoundment at the owner's expense. Vendor parking will be provided to vendors displaying appropriate "Vendor Parking" passes on their front mirror or in their front window dashboard.
3. No motorized means of transport such as golf carts, motorcycles, motor scooters, mopeds, motorbikes, bicycles, tricycles, roller skates, roller blades, skateboards or scooters are permitted in the SALE AREA. This does not apply to such equipment that is for sale and remains in a vendor's stall OR such equipment that is operated by a disabled person.
4. No tape, nails, staples, tacks, screws, etc are to be used on any wall or post.
5. **No dogs or other animals**, except assistance dogs, are allowed in the SALE AREA. Owners are responsible for leash and cleanup laws.
6. No smoking in any building or covered area.
7. No selling of food or beverages including, but not limited to, pop, water, etc. The Fairgrounds holds exclusive rights to selling food and beverages.
8. **All merchandise, vehicles, trailers, tent stakes, etc must be within the boundaries of the assigned Swap Meet stall AND must have a clear space of 3 feet around all FIRE HYDRANTS!**
9. The following types of merchandise ARE NOT to be displayed, offered for sale or sold: guns of any type (including pellet or BB guns – whether operational or not), knives, crossbows, bows or arrows; martial arts equipment or any other type of weapon. Toy guns and small pocketknives are OK.
10. Dry Camping is permitted in the Sale Area with payment of \$25/night.
11. No vehicle parking is permitted on the road in front of the Sale Area RV spaces.
12. Automobiles, trucks, motorcycles, etc as well as free standing engines, that will be operated, are not permitted in buildings or covered areas during sale hours. Loud and noisy generators are not allowed.
13. No loud music, stereos or games are permitted.
14. **Vendors are responsible for cleaning up their stalls before leaving! Any items left over such as tires will be charged at \$50/tire to your account.**
15. The Sale Area must be vacated by 5:00 pm on Sunday! Vehicles will not be permitted in Sale Area until 2:00 pm on Sunday to remove items. Any merchandise remaining after 3:00 pm is subject to disposal and vendors will be billed for that expense.
16. The Puget Sound Regional Group, Evergreen State Fairgrounds, any assisting clubs or personnel working this event, are NOT responsible for damage to or loss of property.

CONDUCT

1. No alcoholic beverages of any kind are permitted in the Sale Area.
2. The Swap Meet committee expects full and complete compliance with the Swap Meet Rules and all requests made by Swap Meet officials. Anyone not complying may be asked to leave immediately **without refund** and/or barred from future Swap Meets.
3. Swap Meet committee has the final say on all disputes, including what constitutes inappropriate behavior.

Vendor load-in and Code of Conduct

Welcome to this year's Monroe Swap Meet at the Evergreen State Fairgrounds. Vendors can start lining up at 6:00 am on Friday, May 15th in the Vendor Parking Lot off Cascade View Drive on the east side of the fairgrounds.



Please have your mirror tag hanging inside your vehicle with all your information filled out including your cell phone number. Big rigs and trucks with trailers use the far most Southern lane to stage. The vendor gates will open at 12 noon or earlier, so be prepared to move any time after 11:30 am.

If you don't know exactly where your stall is or it's your first time, there will be a full-size stall map at the vendor entrance which will show you exactly where you'll need to go. Please have patience during this time because there will be a lot of vehicles moving around to unload their wares. Each area has an Area Captain that can help with any issues that may arise.

We value the safety of all vendors and attendees during our event. We do not allow threats or aggressions:

Threats and Aggressions include:

Disrespectful language

Acts or threats of violence

Insults based on gender, religion or race.

Political banners, flags, decals, handouts or slogans are also banned as well as inappropriate language.

Please be kind to our staff as we're all volunteers trying the best we can to accommodate everyone's needs. Please refrain from yelling or any rude behavior, none of that will be tolerated. We will have both the City of Monroe Police and the Snohomish County Sheriff on duty during the event.

The Car Corral (on the west side of the fairgrounds off 179th Ave. S.E) will open at noon to sell your vehicle or projects on trailers. They can stay in the lot from noon on Friday to 2pm on Sunday, we'll also have security on both Friday and Saturday night.

To accommodate customers who buy items that need to be picked up, we will have a drop-off and pickup area in the same parking lot (area 32) at the Car Corral. Just tell the staff at the entrance that you're picking up or dropping off parts (one hour limit for parking).

For questions, T-shirt sales, electrical drops, lost & found, first-aid or reservations for next year please go to the administration area in building 600 which is just east of the main building 604. Fairgrounds staff will be on site to handle any emergencies.
